Salem Chapel Public Consultation – March 2021

Nantyglo and Blaina Town Council

Salem Chapel - Public Consultation

Public Consultation:

Members of the public are invited to participate in the public consultation being carried out by Nantyglo and Blaina Town Council in respect of Salem Chapel, High Street, Blaina.

Introduction:

Salem Chapel is a Grade II listed chapel located opposite Blaina Post Office in High Street, Blaina and has previously been regarded as important to the regeneration of the town centre. In 2002 it was purchased from the Baptist Union by the then Town Council for community use and to continue to allow the Baptist Union to use the chapel as a place of worship.

A long term lease was subsequently agreed with the Nantyglo and Blaina Charter Group, through which the Charter Group became responsible for the day to day running and maintenance of the Chapel. In 2009/10, the Charter Group successfully applied for a number of grants and a part refurbishment of the building was carried out. In 2011, the Charter Group successfully applied for a further grant which funded a Chartist Exhibition in Salem Chapel.

In 2015/16 a building inspection identified extensive dry rot in the ground floor of the chapel. A full structural survey was subsequently commissioned by the Town Council and this revealed other serious concerns such as damp and defective rendering.

Current Situation:

Following a period of discussion with the current Town Council, it became apparent that the Nantyglo and Blaina Charter Group would not be able to provide a significant funding contribution to the cost of the repair work (whatever their proportion of responsibility under the leasehold agreement). Consequently both parties have agreed to terminate the lease by mutual agreement. Similarly, the Baptist Union has relinquished their right to hold any religious services in Chapel.

The chapel is now in need of extensive repair/refurbishment with an estimated cost in excess of £50,000. Regrettably and despite repeated efforts, the Town Council has not been able to secure any substantial grant aid from external funding bodies to carry out the repairs required.

Clearly a solution must be found, particularly as some existing costs (insurance, inspection, utilities, etc.) still have to be paid. However, the Town Council would be reluctant to levy an increase in the annual precept to fund this work, as this would further burden the local community by increasing the local council tax at a time when many families are struggling as a consequence of the Covid19 pandemic.

Consultation:
