Dear Tracey,

I hope you had a good Christmas and may I wish you all the best for the New Year!

I have been asked to write to Nantyglo and Blaina Town Council on behalf of a community group, Friends of Coed Cae House, which is currently operating as a Community House at 101 Attlee Road, supported by Tai Calon and others. I am sure you and the Town Councillors are already aware of this group which offers support and activities for families and young people, operates a food pantry, a breakfast club in the school holidays and enables Flying Start to have a (rather cramped) meeting place since they had to leave the spacious Scout's Hall two years ago.

As you can imagine, the need for such a facility is very great in the present dire financial climate. Unfortunately, the small size of 101 Attlee Road means that they are unable to accommodate larger groups and their activities are necessarily restricted, in spite of growing demand. For example, they recently teamed up with Blaenau Gwent Food Partnership to provide healthy eating courses. Ideally, they would like a garden to grow food and a much larger kitchen. [Malnutrition, as evidenced by our high obesity rates, is a serious health problem in BG where our life expectancy is ten years less than neighbouring Monmouthshire].

Last year, it came to their attention that the Scouts Hall (formerly Coed Cae Community Centre) at the end of Attlee Road would be vacated by the Scouts as they no longer had a need for it. As you probably know, the community centre is a very large, purpose-built facility with an enormous hall, several rooms, a kitchen and sizeable grounds. I am told that it was actually paid for by the community years ago and only passed into Council ownership when, for some reason, it was no longer required and was then leased to the Scouts.

Times have changed (along with the climate) and there is a growing need and desire from communities to have their own facilities near to their homes (one in three households in

Blaenau Gwent has no car). The building and grounds would provide an ideal place for the myriad of activities which you'll find in the draft business plan annexed to this e mail.

Realising early on that the project needed experienced, like-minded partners, contact was made with Sgiliau, Growing Spaces and Mens Den. These organisations expressed great interest (especially after a tour of the building!) and, with the help of Tai Calon, the draft business plan was drawn up - providing details of those organisations and detailing the different types of activities which could be considered suitable at that site.

I would point out that the business plan refers to a cooperative but, having discussed matters with Huw Lewis of GAVO, they will be forming a CIC (Community Interest Company) which will be the body responsible for holding the lease and the administration of the building and activities. Drawing up the documents for incorporation has already started and is not a lengthy process.

I am sure that Nantyglo and Blaina Town Councillors will be delighted to learn of this initiative which not only has the potential to enhance the often difficult lives of those living around the Coed Cae area, but also the whole of Nantyglo and Blaina which would benefit from such a facility in its midst — especially if the longer term plans around renewable energy are realised. If you would like anyone from the CIC to give a presentation to the N&BTC in due course I am sure they would be only too happy to meet up with you and involve you in this endeavour.

Currently, the building is being assessed by BG's technical team as obviously the electrics and heating need to be in safe working order before a lease can be signed. They are awaiting the outcome of this assessment (somewhat random figures of £100,000 then £60,000 have previously been mentioned). Meanwhile, they asked me to let you know that they intend to apply to N&BTC for support and funding to enable this project to proceed as soon as possible. I have downloaded your grants application form which will be completed once the CIC has been formed and we have a better idea of the cost of work to be undertaken in the first couple of years.

I note that N&BTC currently carries over £120,000 in reserves each year, so we're hopeful that a very substantial grant could be made towards this most worthwhile project – what better use of public funds could there be, after all?!?

I would be most grateful if you would forward this e mail to N&BT Councillors so that they already have some background information when the group formally submits its application for funding.

Meanwhile, if anyone has any questions, please don't hesitate to ask. You'll understand that this proposal is in its early stages and we'd appreciate any feedback or suggestions from anyone involved with the well being of those living in Nantyglo and Blaina. Peter

Business Plan: Cooperative venture to transfer the lease of the building and land in the Coed Cae Blaina area from the local authority.

1. Executive summary.

This business plan outlines the establishment of a cooperative venture comprising 3 charity partners, aimed at securing a lease of a building and land from the local authority. The cooperative's mission is to support and empower the local community by providing services that cater to the needs of the following families, young people in education and training, individuals with mental health challenges, and those seeking alternative health and well-being opportunities through garden and vegetable cultivation. By fostering community engagement, our cooperative aims to build a stronger, more sustainable future for all.

2. Introduction.

The purpose of this cooperative venture is to bring together the expertise, resources, and shared vision of three organisations to acquire and manage a building and accompanying land from the local authority. This facility will serve as a foundation for a community-focused initiative, that combines various support services with gardening and vegetable growing activities and much more.

3. Cooperative partners.

The cooperative comprises four partner organisations, each with a distinct focus on expertise, collaborating to achieve the shared goal of community empowerment:

Partner 1: Sgiliau

was established in May 2016 primarily to work with young people who have left school and are 'NEET' (not in employment, education, or training) as well as with school pupils who are at risk of becoming 'NEET' after they leave school. In Blaenau Gwent Sgiliau has delivered many very successful programmes working with young people since 2016 from our centre in Brynmawr and outreach projects in various communities throughout Blaenau Gwent. Over the past seven years, we have I Levitt over 1 million to blind the Gwent to support very vulnerable young people with multiple needs such as: -

- additional learning needs.
- Learning difficulties.
- Offending behaviour.
- Behavioural issues.
- Mental health issues.
- No qualifications.
- Low level or no school attendance.
- Unemployed.
- Not in educational or training.
- Drug and alcohol issues.
- Antisocial behaviour issues.

To address these issues, Sgiliau I have secured funding from the following initiatives specifically for Blaenau Gwent.

- Traineeships (funded by the Welsh government).
- Active inclusion (funded by WCVA).

- Community renewal fund (BGCBC and the UK government levelling up).
- Employment skills programme (Welsh government).
- Kickstart (department for work and pensions).
- Thriving Minds (UK youth grant).
- My best friend (grant to support young women and non-binary young people).
- Winter of well-being (BGCBC).
- BGCBC inclusion services (supporting very vulnerable school pupils).

We have supported over 700 young people in the past seven years and delivered all the outcomes required for each of the above programmes such as employment, further education, training, volunteering, and qualifications. During the COVID-19 lockdowns, we only closed for the first lockdown from March to June 2020 and remained open after as we were working with very vulnerable young people who needed social interaction and face-to-face support. Much of our work is around creative arts and using technology as well as promoting the use of the Welsh language hence our name 'Sgiliau' Welsh for skills.

Partner 2: - Growing Space.

A registered mental health charity that was founded in 1992. Growing Space specialises in supporting individuals with mental ill health, autism, or a learning disability to build confidence, develop social skills and improve their quality of life through the provision of therapeutic training, vocational skills, creativity and work experience. Growing space provides a network of support projects across our sites, to develop the skills and knowledge of our participants, whether that be personal development, vocational or employability.

Are accredited and non-accredited opportunities include experiencing and interacting with nature, horticulture, woodwork, social enterprise, personal development and life skills, well-being digital and creative arts, technology, employability skills and information technology. For many of our participants, engagement is one of many steps towards voluntary work, sustainable job opportunities, or further education. As an organisation, with 30 years of experience, Growing Space recognises that social exclusion is often experienced by people with mental ill health. Growing space therefore really makes a difference in getting people back into society, reducing social isolation and loneliness, and combating the stigma associated with mental ill health, autism, or a learning disability by concentrating upon each participant's ability and not inability. Growing space has supported many participants through their process of change, where they have opportunities to form new friendships, some have significantly repaid former poor relationships with families and friends. Growing space encourages participants to see themselves in a positive and constructive light and helps to maximise their unlimited potential with so many examples of how self-esteem and self-worth have increased through involvement with the projects. In Blaenau Gwent, we have two well-established community projects.

Our site Terence Gardens is one of our newest sites and has undergone A tremendous transformation thanks to the hard work of all on site. You will find a decked area, a memorial garden area, an art studio, a site café, and a wood workshop, our 25-foot polytunnel will also help extend the growing season. The site offers the opportunity to spend some time outdoors, whether that be exerting physical energy, or taking time to relax from everyday pressures. There is the opportunity to get involved in horticulture, art, craft, woodwork, or the cafe, with participants also working towards accredited and non-accredited qualifications. We offer a variety of creative woodwork or arts and crafts activities that participants and volunteers can get involved in, and we love getting ideas for

future activities too. We are very these activities using as many natural objects as possible such as wooden mobiles wooden love spoons painting on slate, spray painting and other craft activities. While supporting participants we also make this a sustainable project that can benefit the local and wider community. There is the intention to create an onsite shop that will sell some amazing crafts created by some very talented participants and volunteers, as well as a plant shop where you can buy your garden seeds and cuttings. Staff are also working towards offering healthy fruit and veg to the local community. Growing space levers in funding from a variety of sources supporting adults in the Blaenau Gwent including:

- Aneurin Bevan University Health Board.
- BGCBC.
- Welsh Government.
- WCVA.
- Coalfields Regeneration Trust.
- Grants from various bodies.

Brynithel:

The carpentry workshop operates on our site by Penrhiw quarry in Brynithel. Participants can learn carpentry construction and joinery skills, whilst also gaining qualifications. We saw many of the items made for sale in our social enterprise shops.

We have supported many hundreds of adults with mental health issues living in Blaenau Gwent over the years helping them manage their condition as well as supporting them via many therapeutic activities as well as securing them employment, training, and education opportunities as well as qualifications.

Partnership:

Sgiliau and growing space have worked in a very close partnership since 2016 developing joint initiatives and sharing resources, including staff, and expertise. This partnership goes back even further to 2004. Before Sgiliau was established, it was previously part of ACT- Learn About, which was acquired by Cardiff and Vale College in 2016. Sgiliau retained the creative arts, music and technology provision focusing on young people and continuing the partnership working with growing space.

Partner 3 Friends of Coed Cae Community House.

Friends of Coed Cae Community House I believe that the work and activity that they do and provide are integral to supporting the needs of this super output area. Coed Cae has been a forgotten community for many years with little investment to improve the lives of its community members and we intend to forge forward to effect change. We play an integral part within our community with support from all of its members through activities such as: -

- Provide a food pantry three days per week.
- Breakfast club during school holidays. Fit and fed in partnership with Aneurin Leisure during the school holidays.
- Provide weekly space to flying start BGCBC.
- Provide activities for the children and young people at key events EG Christmas, and Halloween.
- Tai Calon staff provide advice/repair surgery fortnightly.
- Provide healthy eating courses to adults and young community members.

Partner 4 Men's Shed.

It is all about well-being. As a gender, men do not tend to form the same support networks and groups as women, and traditionally men in Wales have talked and socialised at the local pub, or during sporting activities. Life presents many challenges; retirement, unemployment, physical or mental health — men often find themselves with time on their hands, have become socially isolated or lonely. Men Sheds Cymru volunteers offer a health-by-stealth approach encouraging friendships, community and service networks through the formation and support for Men's Shed. The inclusive ethos we provide offers shedders a sense of belonging, acceptance, and fellowship experienced shoulder to shoulder through shared activities. The Coed Cae is an area that would be well suited to position a man shed in the proposed building to support local men of all ages and abilities in being able to live a life of health and well-being by being able to interact with fellow Men shed members.

4. Business Concept.

Our cooperative venture aims to create a multi-faceted community hub that addresses the needs of different target groups. Through a combination of support services and gardening activities, we will foster physical and mental well-being, skill development, and community cohesion.

Target Beneficiaries: -

- Young families such as parenting workshops, childcare assistance, family counselling, and recreational programs
- Young people in education & training, various courses will be offered as well as qualification programmes that will be offered to individuals, including mentoring, tutoring, vocational training, and career guidance.
- Mental health support, such as counselling, support groups, and wellness workshops, would include woodcraft (men's shed).
- Alternative health & well-being through gardening, growing vegetable initiatives, highlighting the therapeutic benefits, education workshops, and community involvement opportunities.
- Housing matters regarding Tai Calon workshops.
- Employment and job search (Job Centre)
- Community winter-warm hub.
- Community hub, for all information and support.

4.1 Legal Structure & Governance.

The cooperative will be run equally as a joint venture and all parties will sign up for this in a written agreement when taking the lease for the land and building from the present leaseholders (Local authority), Decisions regarding the building and land will be made by all interested parties that have been signed up on the lease.

5. Target Community

The area where the community centre and land are situated is based in the Coed cae area of Blaina which is described as a 'super output area' The area itself is an isolated area with high unemployment and anti-social behaviour, within a community such as this it brings its challenges and needs, all of which the cooperative aims to address.

5.1 Marketing & Outreach Strategy.

Once the partnership has been formed the marketing & outreach plan will be to use social media, campaigns, community events, and partnerships with local health boards/social services.

6. Financial.

We will hope that the local authority will be able to fund a basic get-you-in package, and an agreement with the cooperative to add funds to make the initial handover of the premises meet the safety standards required, to be able to operate with immediate effect. (a discussion with Sgiliau and the local authority on this matter will be set up to negotiate initial handover costs)

As a cooperative, we will be able to apply through various streams such as grants/lottery funding etc. to financial support the ongoing various activities run at the centre. There will also be a community café set up at the centre which will be self-sustainable. There will also be an opportunity to hire rooms out for meetings/courses etc (Flying Start already rent out one area of the building). when the centre is back to full functionality. We will be looking at setting up a craft shop, and a flower & vegetable seed shop. Grants for Heat pumps & solar panels will also be applied for which can significantly contribute to reducing carbon emissions and prompting sustainability, the grants that we will be applying for and subsidies or other financial incentives to encourage the adoption of renewable energy technologies like the heat pumps and solar panels, thus saving energy bills in the long term.
