

Child Poverty Income Maximisation Plan

Given the acute financial pressures many families are likely to be experiencing as a result of the Covid-19 pandemic the Welsh Government published its Child Poverty Income Maximisation plan in November 2020. The plan sets out a set of practical actions that ministers will work on over the a six month period to help maximise the incomes of families living in poverty in Wales, help reduce essential living costs and provide support to families to build financial resilience.


Whilst take-up statistics are not readily available at a lower geographic level than Great Britain; we do know that welfare benefits are significantly under-claimed in Wales. For example, recent analysis estimated that in Wales during 2018-19

- up to 55 thousand families who were entitled to receive Pension Credit did not claim the benefit
- up to 52 thousand families who were entitled to receive Housing Benefit did not claim the benefit
- up to 13 thousand families who were entitled to receive Income Support or Income-related Employment and Support Allowance did not claim the benefit

It is estimated that across the Great Britain around £16 billion a year of means-tested benefits provided by the Department for Work and Pensions and HM Revenue and Customs is not claimed. Proportionally, that is £752 million a year not being claimed by people in Wales who are entitled to this money. Whilst it is difficult to make reliable estimates of the under claims of disability benefits, probably half of the people in Wales, who are entitled to a disability benefit, are not making a claim.

The primary objective of the campaign is to raise awareness of the benefits available to families in Wales and encourage them to check what they





We have now given a total of 463,178 vaccines (a combination of 1st and 2nd doses) across our Health Board area. We have vaccinated 8 out of 10 adults aged 40-49, and currently vaccinating those aged 35-39.

People in Blaenau Gwent, Caerphilly, Monmouthshire, Newport, and Torfaen who have a wider range of symptoms and generally feel unwell are now encouraged to get a free test for coronavirus.

As well as the three classic coronavirus symptoms of a fever, a new continuous cough or a loss or change of taste and smell, you can get a test with other symptoms too.

These additional symptoms include:

 Flu-like symptoms including aching or painful muscles, excessive tiredness, persistent headache, runny nose or blocked nose, persistent sneezing, sore throat and/or hoarseness, shortness of breath or wheezing.

You should also book a test if you:

- Are generally feeling unwell or if you've recently been in contact with someone with coronavirus.
- Have any new symptoms, or a change in symptoms even if you have previously tested negative.

We're operating fourteen testing facilities across the region and getting a test is now even quicker, easier and more convenient with results in most cases returned within 24 hours.

NHS 'Help Me Quit' Supports Blaenau Gwent Food Banks

Staff from Aneurin Bevan Health Board's Help Me Quit Team supported the Blaenau Gwent Foodbank after seeing a recent appeal for bags on Face Book.

Sian Harris, HMQ Community Advisor for Blaenau Gwent, delivered 80 HMQ bags and pens to Wayne Evans who was thrilled to accept them. Since lockdown began, Blaenau Gwent Foodbanks have supplied more than 30,000 meals to 1,443 families including 2070 adults and 1159 children and they were delighted to receive reusable bags in which to distribute the food.

Blaenau Gwent has the highest number of adult smokers in Aneurin Bevan area and Sian was keen to support those wishing to quit by leaving details of the HMQ service. Smokers can phone 0800 083 2219 or text HMQ to 80818 where specially trained staff offer free nicotine replacement therapy products and behaviour support to help quit for good. Many smokers are choosing to quit for health and/or financial reasons in 2021.

Sian was very interested to learn that the Blaenau Gwent Foodbank supports a range of dietary requirements including gluten free, lactose intolerant and diabetic diets and offers a range of food parcels dependent on the recipient's situation. Donations for Blaenau Gwent Foodbank can be left at the following supermarkets – Tesco in Ebbw Vale and Abertillery, Asda in Brynmawr and Waitrose in

Abergavenny.


Pharmacy Services

Visiting your local pharmacy is a great way to access prompt advice and treatments for common conditions.

Some of the work traditionally done by GPs is now done by pharmacists instead. This includes giving prescription-only medication for a number of minor ailments without the need to see a doctor. And, like other medications in Wales, these are also free.

You have to register with the pharmacy to use the scheme, but the process only takes a few minutes.

Consultations are carried out in a private room and if the pharmacist decides you still need to see a doctor they will refer you.



Optician

If you have an eye problem that needs urgent attention, please contact your local optician.



If you have a problem outside of normal working hours, ring 111 for advice. Conjunctivitis (bacterial) and dry eye can be treated by pharmacists under the common ailments scheme. See this page for more details or visit your local Pharmacist.

Most opticians also have optometrists who are part of the Eye Health Examination Wales Service. If you have a problem with your eyes like red eye, flashing lights or floaters, you can go there instead of your GP. It won't cost you anything. Optometrists in Wales also offer a Low Vision Service, so you don't have to go to a hospital to be assessed.

Dentist

If tooth or gum pain develops, contact your own dentist as they can provide emergency treatment.

If you receive urgent dental treatment, the charge will be £14.70 unless you are exempt from paying NHS charges. If you do not have to pay for treatment, you will be asked to provide evidence of this when you attend the practice.

Toothache on its own (for example, toothache with no other accompanying symptoms or signs) is not a dental emergency. Patients with toothache should not attend an Emergency Department.




Hospital Admission Avoidance Project



Just to confirm receipt today of your donation of £400 paid into our bank account online for the benefit of families in the Nantyglo and Blaina area.

For you to be up to date since the beginning of March last month and to date we have fed 58 people in Nantyglo and Blaina comprising 34 adults and 24 children from 28 families. This has placed 522 meals on tables. I do appreciate that there are other community groups and Foodshares that families use in the area so possibly our figures maybe the tip of the iceberg. I would appreciate that you get the message out in the area that we are willing to help families who have short term crisis situations and they can get a Foodbank Code only voucher from the DWP/Job Centre where they send us a food requisition slip or Tai Calon can help. CAB also Blaenau Gwent Benefits section Families First etc and many more agencies that they may be working with. If you feel there is demand, you as a council can act as a Registered Agency to and let me know if that would help. I'm sure you busy enough though. Clients normally are allowed 3 Foodbank parcels in a 6mth rolling period. The idea is to not make them rely on us but to empower them to work on the issues and get them out of their difficulties.



Meeting is finished. It was mainly aimed at the re-opening of licenced premises next week but I picked out the following:

Track & trace details should be taken for all staff and visitors (this should include name, telephone number, date of visit, arrival time and departure time).

If a staff member has a positive test result – they need to leave the work place asap. Anyone they have been in contact (other staff members or visitors) will need to be identified asap. If possible, identify where they have been within the work place and what they might have been in contact with - surfaces, equipment, vehicle etc. Track & trace should be informed as soon as possible and provided with as much information as possible.

If a visitor has a positive test we should contact track & trace as soon as possible. They will need to know pretty much the same information as per staff above.

Track & trace records can be handwritten or electronic as long as they are legible. These records should be kept for 21 days.

Businesses should ensure that their risk assessments are up to date and include track and trace actions.

Regular workplace testing is only available at the moment for businesses with 50+ employees.

The top priority currently is still - work from home if you can do so, social distancing (2m), use of masks and PPE. Put in place any other controls you can i.e. screens. Handling cash should be avoided if possible. Review internal covid controls regularly and respond quickly to breaches.

Be aware of high risk areas within the work setting - some examples are: entry areas, toilets, break rooms, shared working areas.

There was also lots of information about how track & trace works, how testing works, the types of tests that are available, Covid terminology etc







Independent Remuneration Panel Wales

Members Allowances April 2021

Introduction:

Members will be aware of the annual report of the Independent Remuneration Panel Wales (February 2021) and One Voice Wales' report/advice on implementing these determinations.

Purpose:

One of the requirements of this report if for each Town/Community Council to implement the mandatory determinations stated within the report and to consider and, if appropriate resolve any other determinations. This report does not include any information contained within the IRPW Annual Report which has remained unchanged and as such does not require a resolution.

Report:

The Council is advised that the Nantyglo and Blaina Town Council is still classed as a 'Group B' council (i.e. which has an income or expenditure of between £30,000 and £199,999) table 8 page 40 of report.

Determination 42:

All community/town councils must make available a payment to each of their members of £150 per year as a contribution to costs and expenses.

Advice:

One Voice Wales has advised that, at the moment, this payment is **taxable** and as such will need to be processed via the Council's payroll system. Members may wish to consider and **resolve** if this payment is payable in three instalments in arrears OR as a single payment in arrears. Members are advised that the allowance paid in one single instalment COULD result in a nominal amount of employer's & employee's

National Insurance being payable by the Council. Whilst payment of the allowance in instalments would NOT result in employer's national insurance contributions being payable, it is likely that the payroll costs would increase.

(n.b. employer's and employees' national insurance payments are only applicable to those NOT in receipt of state retirement pension).

Whilst receipts are not required for this allowance, it is good financial practice for Members to retain any receipts relating to any such expenditure.

As previously, any Member NOT wishing to receive a part or whole of the payment must state this in written form to the Clerk or complete and return the proforma.

Determination 44:

Community and Town Councils in Groups B or C can make an annual payment of up to £500 each to up to 5 members in recognition of specific responsibilities. This is in addition to the £150 payment for costs and expenses. (n.b. para 13.16 of the IRPW report 2021 states that 'in all cases, a Councillor can only have one payment of £500 regardless of how many senior roles they can hold within their Council'.)

Members may wish to consider and **resolve** for the 2021/22 civic year which positions are considered as Senior Roles and if these positions are eligible for the £500 annual allowance.

As these payments are **taxable** and as such will need to be processed via the Council's payroll system, Members may also wish to consider and **resolve** if the payment is still payable in three instalments in arrears OR as a single payment in arrears. Members are advised to consider the financial implications as outlined above when considering this.

Determination 48:

Community and Town Councils can provide a Civic Head payment to the mayor/chair of the council up to a maximum of £1,500. This is in addition to the £150 payment for costs and expenses and the £500 senior salary if these are claimed

Members are advised that in the 2021/22 budget and precept this allowance was resolved as £500. The IRPW report for 2021 states that any payment made under this determination DOES NOT relate to any support costs and that this allowance is purely for undertaking the role of Town Mayor. Any support costs incurred should relate to the tasks and duties of the role and the council should make a funding decision in relation to such support as they deem appropriate for the levels of civic leadership they have in place (13.23).

A Civic Expenditure budget has already been resolved and established for 2021/22 at an amount of £400 (January 2021).

Determination 49:

Community and Town Councils can provide a Deputy Civic Head payment to the deputy mayor/deputy chair of the council up to a maximum of £500. This is in addition to the £150 payment for costs and expenses and the £500 senior salary if these are claimed.

Members are informed that the above (determination 49) criteria also applies in this case. Members are additionally advised that in the 2021/22 budget and precept, this allowance was resolved at £100.

The allowances for both determination 48 & 49 are **taxable** and will be processed via the council's payroll system.

Please Note:

It must be noted that clarification has been sought and received in respect of Members Allowances and the information contained within the IRPW Report 2020.

- The allowances payable to both the Town Mayor and Deputy Town Mayor are legislated by primary regulation (Local Government Act 1972 ss 15(5)) which is reiterated in Determinations 48 & 49 detailed above. The positions of Town Mayor and/or Deputy Town Mayor therefore should not be determined and remunerated as a Senior Position. This is to avoid any position being remunerated for more than once. If a Town Mayor / Deputy Town Mayor is also Chair of a Committee which is deemed as being a Senior Position within the Council, then (if resolved) a senior allowance may be payable in respect of that position. In all cases, a Councillor can only receive one senior allowance (£500) regardless of how many senior roles they hold within the Council.
- Members are further informed that the Town Council must publish details of all payments made to individual members in an annual Statement of Payments. This information must be published on Council noticeboards and / or websites and provided to IRPW by 30th September following the end of the year.
- In all cases, it is up to each individual member if they wish to 'opt out' of receiving any allowance (whether in part of full). This can be done by the individual member completing the 'opt out' form' or informing the Town Clerk/RFO in writing or by e-mail.
