

8. any contract for goods, services or works made between the authority and you, a firm in which you are a partner, a company of which you are a director, or a body falling within sub-paragraph 7;	
9. any land in which you or a member of your family has a beneficial interest and which is in the area of the authority;	
10. any land of which the landlord is the authority and the tenant is a firm in which you are a partner, a company of which you are a director or a body falling within the sub-paragraph 7;	
11. any land in the authority's area in which you have a licence (alone or jointly with others) to occupy for a month or longer;	
12. any visit outside the United Kingdom for which the authority has paid for or will pay;	
13. membership or position of general control or management in any organisation including: a) private club or society such as the Freemasons, recreational club, workingmen's club or private investment club; b) organisation whose principal purpose includes influencing public opinion or policy such as a lobby group; c) trade union or professional association; d) company, industrial and provident society or other organisation which has charitable objects.
