Town Centre Loans

The Town Centre Interest-Free loan scheme delivered by the Town Centre Team has been a significant catalyst for both property owners and local businesses, and it has played a crucial role in reactivating vacant properties. This initiative provides interest-free loans for underutilised commercial properties within the Town Centre, thereby facilitating their transformation and reintegration into the local economy. These loans, subject to an affordability assessment, a robust business plan, and the Council's application of the necessary legal charge, have been instrumental in revitalising properties. The effectiveness of this scheme is underscored by the successful administration of over 20 loans, highlighting its substantial contribution to the vibrancy and growth of the Town Centre's in Blaenau Gwent.

Meanwhile Use

The Meanwhile Use Scheme delivered by the Town Centre Team is a strategic initiative designed to provide short-term rental support to new businesses that introduce unique and distinctive offerings to the Town. The scheme's objective is to attract a diverse array of businesses. However, it's important to note that businesses such as hairdressers, takeaways, barbers, and other businesses that could potentially cause displacement are not considered under this scheme.

To ensure a smooth and efficient process, we require a comprehensive business plan from all interested parties. This plan should clearly illustrate the unique proposition of the proposed business, as well as its potential contributions to the local economy and community.

This scheme has proven to be successful, having supported numerous businesses that have either continued to rent the property or have transitioned into larger premises within the town centre.

Shop Local Scheme

The "Shop Local" initiative, overseen by the Town Centre Team, aims to promote local Town Centre businesses and invigorate the local economy.

This initiative allows businesses to exhibit their offerings via BGCBC social media channels. It facilitates the promotion of their business by providing their contact information and their products or services.

Significantly, this scheme has already promoted more than 200 businesses and continues to expand. This is indicative of the scheme's positive influence on promoting independent retailers.

Furthermore, this service is offered at no cost to the businesses. This ensures inclusivity, allowing all local companies, irrespective of their scale or resources, to take part in the scheme and reach a broader customer base.

Dear Colleagues,

I am writing to encourage you to get involved in our listening programme on 20mph. This has been a really challenging period for transport in Wales and I recognise that councils have been at the frontline through some incredibly turbulent times.

As we have always acknowledged with a change of this scale, we were not going to get the speed limits on all restricted roads right from the start. We now want to support all highway authorities to get the right speed on the right roads and achieve more consistency across Wales on which roads should have a 30mph limit.

Against that backdrop, it is not surprising that some colleagues are cautious about reigniting the debate on 20mph at a time when it was beginning to calm down in some parts of Wales. I absolutely recognise those concerns and genuinely welcome that constructive criticism and challenge.

I want to build from the consensus that 20mph is right around schools, hospitals and in built up residential areas. Through partnership working and by supporting highway authorities to make changes where it is right to do so, I believe we can absolutely make 20mph a success story for Wales.

However, we cannot escape the fact that 20mph has served to polarise the people and communities we serve. Against that background, I felt we should take a step back and listen to the views of everyone involved. I take full responsibility for that reset, and it is not a reflection on highway authorities who have worked so hard on the implementation of this policy over the past two years and more.

To support the National Listening Programme I have instigated, we have published a webpage to help signpost people towards the relevant highway authority where they want to feedback on specific speed limits. Your local knowledge and community engagement make you key partners in this process.

I encourage you to contact your local council, or the Welsh Government for trunk roads, about any roads or streets in your communities where you feel the speed limit has not been correctly applied. You can view a map of all Welsh trunk roads on DataMapWales.

We want you to let your highway authority know if you think a specific road should:

- change from 20mph to 30mph
- change from 30mph to 20mph
- stay at 20mph

When giving feedback please:

- be clear and precise about which section of road you are talking about
- · give reasons for your views

In my discussions so far, it has become clear that in many areas only a handful of changes will be made, whereas in other places, more roads are likely to revert to 30mph.

Through the drumbeat of regional meetings we are putting in place with the support of Transport for Wales, and with the help of the County Surveyors' Society Wales, we want to co-create a framework that supports highway authorities to make the right decisions for local roads – particularly when those calls are finely balanced.

That framework will be published before summer recess. After the summer break, we will continue to support highway authorities in the implementation phase of assessing roads, making of traffic regulation orders and finally in the implementation of changes on the ground. We acknowledge that it may take several months from September onwards before we see any changes on the ground.

My officials will then focus on prioritising guidance for other speed limits where people live.

To enable us all to focus fully on speed limits, we are pausing work on the development of a new Road Safety Strategy and pavement parking.

Hi Tracy

All pretty easy to answer. There are 2 cameras in Blaina currently, although one has just been upgraded to being a 180 camera, which means it has a view up and down the street, so like having a new camera (2 views from one pole).

One is located on the corner of High St and Hope St, with a view of High Street down towards the junction of Church St (looking south). The other one, which is new is located opposite the Co-op, it now looks North up towards Coop up High St, and also down High Street towards Cwm Celyn Road. This was improved earlier in the year, from discussions with the Councillors and Police. We can get some maps out to you (Kris will send the most up to date maps). The is also infrastructure on other columns/poles which moves the signal to the library i.e. it is wireless transfer not hard wired.

In terms of who is responsible, nice and easy - I am. As the Service Manager, reporting to Head of Service Sarah King. The SIRO is Rhian Hayden – Senior Information Risk Officer. If any discussions are needed on it with anybody, or your Councillors want to discuss anything it is through me . Kris Herridge also cc'd is included. Anything on the system is via us, our contract with Caerphilly is operational delivery ie they deal with the footage etc. We also have an infrastructure contract too with IDS. I should add though our Cabinet Lead is Councillor Helen Cunningham.

I'd also add that in the meeting the other day that we had, Councillor Hillman's perception of cameras numbers, and costs is also a little linear though, as the costs are not just divided by 55 (number of cameras), the running costs for a zone, all have similar fees, regardless of the amount of cameras.

Furthermore, in Blaina, there is also cameras not operated by us (the Council) that get used by the Police, e.g. Aneurin Leisure Trusts system, down on the bottom roundabout, but this system is self-contained and not as costly as our to operate. Actually purchasing an putting up a camera is relatively inexpensive compared ongoing operating costs.

I'd add as well, Blaina had a big upgrade last year to PSBA connections as well - to take it to Caerphilly Control Room (around 15k investment from the Council) without this

we wouldn't be able to have cameras. Previously, we had 4G cameras, which were massively problematic in terms of accessing and retrieving footage – also the old system only held footage for say 7 days max, as it was internal storage, now it is recorded for 31 days to the library.

I can answer any queries or question needed, and happy to discuss further if the Council want a discussion.





Further to your e-mail.

- 1. The Town Council work with numerous organisations to help improve the community, much of which is outlined in paragraphs below. Since April 2020, the Town Council has made an ongoing commitment to help support residents of Nantyglo & Blaina who are in need by making a monthly financial donation of £200.00 to Blaenau Gwent Foodbank. The total amount donated to date is £9,579.92 and is ongoing. The amount of financial donations provided to both local groups and larger organisations (who benefit the area) is £3,100.21 (since April 2020). The Town Mayor's Appeal has raised nearly £6,000 in recent years for numerous charities such as Pheonix House, Citizens Advice, Wales Air Ambulance, Breast Cancer Wales & Downs Syndrome etc. The annual cost of Christmas lights throughout both Nantyglo & Blaina is approximately £6,000.00 & the Town Council are hoping to (where legally possible) extend & enhance the display. Butterfly nature gardens have been set up in both Nantyglo & Blaina in addition to memorial benches specifically purchased to honour those who have served in the forces. The Town Council has also purchased a number of flags etc to help the community honour organisations and events such as D-Day, NHS Day etc. A large amount of heavy duty Welsh bunting was purchased to enhance the local area although this was unfortunately destroyed by certain individuals. The Town Council actively recognises and celebrates the achievements and hard work of local individuals and groups via the Achievement & Recognition in the Community Awards, Freedom of Nantyglo & Blaina and most recently, nominated Reverend Roy Watson for a honour in the King's Honours List. This nomination has resulted in Reverend Watson being awarded a British Empire Medal.
- 2. The Town Council are currently in the process of finalising legal restrictions which will then allow for realistic plans for the future of Salem Chapel to be decided.
- 3. The Town Council would question the use of public finance on privately owned

businesses (shop fronts) as appropriate, particularly when Blaenau Gwent County Borough Council receive the business rates from such properties. It would be more suitable to make such an enquiry to the local Blaenau Gwent Councillors.

- 4. In 2022/23 & 2023/24 the Town Council arranged and put on the following events: ARC Awards, Nantyglo & Blaina In Bloom, provided bunting & funding for local nursing & residential homes to celebrate the King's Coronation, purchased & erected bunting throughout Nantyglo & Blaina in respect of the King's Coronation, commemorated Merchant Navy Day & Remembrance Sunday, held a week long exhibition in the Council Chamber to commemorate the Battle of Britain (with the RAF), held a service and provided a book of condolence for the community to sign in respect of Her Majesty Queen Elizabeth II, provided financial donations to a number of local organisations & charities, provided £4,800 of funding to Blaenau Gwent Foodbank specifically to help support residents of Nantyglo & Blaina, provided each primary school child in Nantyglo with a gift to commemorate both the Queen's Platinum Jubilee and the King's Coronation, arranged & funded a public commemoration service (with refreshments) in respect of the Queen's Platinum Jubilee, purchased & planted two trees in commemoration of the Queen's Platinum Jubilee. Two Christmas Carol concerts and Christmas Fayres were organised in Nantyglo & Blaina, selection packs & Easter Eggs are purchased for every primary school pupil in both Nantyglo & Blaina every year, which ensures every child receives a seasonal gift without being singled out as 'in need' or 'deprived'. In recent years, a financial donation has been made to the Rotary Club in respect of their Christmas campaign to provide Christmas Hampers to Nantyglo & Blaina residents who have been identified as being 'in need'. Numerous planters throughout both Nantyglo & Blaina are maintained and re-planted three times a year and have been increased in number and size.
- 5. The Town Council has made a financial contribution of £100 towards a number of events put on by Blaenau Gwent County Borough Council, in addition to purchasing and making up over 400 bags of reindeer food for two Christmas events. The financial contribution of £100 is the same as a nearby Town Council whilst a neighbouring Town Council does not contribute to such events. A number of Town Councillors attend and assist fully at such events organised by other organisations.
- 6. The Town Council spend less on wages than most nearby Town Councils and carefully consider all implications when setting the annual precept. Town Councillors are able to claim applicable allowances in accordance with and as set by the Independent Remuneration Panel for Wales. In 2022/23 the total amount of allowances claimed by Nantyglo & Blaina Town Councillors totalled £4,021.80 with tax & NI payments totalling £344.60. Please note that all Town Councillors do not have any IT equipment provided but must use their own. In 2022/23 the total amount of allowances claimed by the four elected Blaenau Gwent County Borough Councillors for the Nantyglo & Blaina Wards totalled £77,971.19 (including pension contributions), an additional total of £4,287.96 for representation on other public bodies. Please note that these amounts do NOT include any tax or national insurance payments which are additional amounts. Furthermore, only 66% of Nantyglo & Blaina Town Councillors claimed any allowances compared to 100% of Blaenau Gwent County Borough Councillors.

- 7. The Town Council is currently considering a number of options with different providers as to provide free cinema or film showings throughout the school summer holidays. The Town Council does not currently fund a youth worker. Abertillery & Llanhilleth Community Council receive grant funding to provide for a youth worker.
- 8. Thank you for your kind comments regarding the Leader of the Town Council and his hard work in respect of the Remembrance Day Parade. The Remembrance Day Parade and service is organised by Blaenau Gwent County Borough Council and the Royal British Legion in all towns throughout Blaenau Gwent. Refreshments have always been made available to any persons. Please note that the Town Council purchases and provides refreshments at a number of events to which members of the public, invited guests and civic dignitaries (including Blaenau Gwent Councillors) are invited to. Such events include (but are not limited to) ARC Awards & In Bloom, Annual Meeting, commemoration events such as Queen's Platinum Jubilee and Battle of Britain exhibition etc.
- 9. The Town Council is currently in discussions with Blaenau Gwent County Borough Council to provide a series (not an individual session) of play sessions in both Nantyglo & Blaina for children aged 4-14 years during the school summer holidays.

I trust that the information answers your queries. I have also attached an application form & information should you wish to apply to join the Town Council & help to improve our local community.
