Members were invited to declare matters of interest either at the beginning or at any time during the proceedings. Members were reminded that all declarations must be recorded in the book provided. **Resolved** to note that Councillor G Morvan declared an interest in Item 3) f.

Two proposals were received. The first was to not pay the optional allowance to help save money for local residents and the second proposal was made to continue the optional payments and allow members to choose individually as they are not required to take all of the allowances.

Members voted in favour of the Town Council paying the optional allowances to those members who correctly claimed them (7 in favour, 4 against and 1 abstention).

**Resolved** that the Town Council pay the optional allowances to individual members who correctly claim the appropriate allowances.
